Admission to ANM/GNM/MPHW(M) Courses in Government/Private Nursing Schools in the State of Haryana for the Academic Session 2018-19

It is for the information of all the eligible candidates desirous of seeking admissions to ANM/GNM/MPHW (M) Courses in Nursing Schools located in the State of Haryana and all the concerned that State Government shall be conducting online Centralized Combined Counselling for admission to ANM/GNM/MPHW(M) courses in Government/Private Nursing Schools in the State of Haryana for the Academic Session 2018-19. The Detail process explaining the procedure for admission to has been notified by the State Government dated 30-08-2018. In view of the **Notification of Indian Nursing Council vide Letter No. F.No. 1-6/2018-INC dated 23-10-2018, the extension for the admission date approved by the worthy President, Haryana Nurses and Nurse-Midwives Council.**

The fresh schedule of the counseling is as under:

2 nd Mop-up/Spot round		
1.	Opening of the portal for fresh registrations only for 2 nd mop up/spot round of counseling	13.11.2018 to 21.11.2018
2.	Document verification of eligibility and original documents and last date of joining the institutes and Fee Deposition	26.11.2018 to 29.11.2018
3.	Last date of joining/admission as per INC guidelines	30.11.2018

- ❖ The candidates who will register on the admission web portal from 13.11.2018 to 21.11.2018 for the 2nd mop up/spot round will be considered only after exhausting the merit list of candidates who have earlier registered on the admission web portal from 17-09-2018 to 25-09-2018 and 15-10-2018 to 20-10-2018.

Note:-

1. The admissions under backward classes shall be subject to final outcome of the SLP No. 21893 of 2018 titled as "Principal Secretary to Government of Haryana V/s Nisha Minor through her father."
2. The candidates will have to deposit the fee in the shape of Demand Draft/RTGS/Credit card to the allotted Institute directly.
3. **If any Institute fails to report the vacancy position as per the specified date, such seats shall be considered filled and allotment to such seats shall not be done.**
4. Final number of seats under each category and in each institute shall be displayed on the admission web portal www.hrnyrsingadmissions.com. The candidates should regularly visit these websites for updates.
5. Reservation and relaxation in age etc. shall be provided to the candidates of different reserved categories as per State Reservation Policy.
6. Any candidate who fails to deposit original documents and the fee to the Institute will not be considered and his/her claim to admission will be forfeited.
7. Any orders of the Hon'ble Supreme Court/Punjab and Haryana High Court/amendments by the State Government/Government of India, Ministry of Health & Family Welfare shall be applicable.
8. Admission shall be made to only those institutes which are recognized and approved for admission from INC/State Government/HNM&MC. The institutes that are unable to get affiliation and such approval shall not be considered for counseling.
9. **ANY ADMISSIONS MADE BY ANY PRIVATE INSTITUTES IN THE STATE AT ITS OWN LEVEL SHALL NOT BE VALID AND SUCH ADMISSIONS SHALL BE CONSIDERED AS NULL AND VOID.**
10. Candidates who have registered earlier on the admission portal from 17-09-2018 to 25-09-2018 and 15-10-2018 to 20-10-2018 need not to be registered again.
