Subject: Regarding issuance of Income Certificate for admission to MBBS/ BDS Course for BC-A & BC-B Candidates.


Please refer to the Notification No. 1282-SW(1) dated 28/08/18 and Notification No. 808-SW(1) dated 17/08/2016 issued by the Welfare of Scheduled Castes and Backward Classes Department, Haryana (copy enclosed).

2. In this context it is brought to your notice that during the Academic Session 2018-19, a number of Income Certificates issued by the District Authorities did not include the Income from salary which led to confusion and misapplication of Income Criteria of many candidates (BC-A & BC-B category) being admitted in MBBS/BDS courses session 2018-19 and subsequent litigations.

Therefore, it has been decided that an additional Income Certificate be issued by the competent District Revenue authorities to all BC-A, BC-B Candidate certifying the Family Income from salary and Family Income from Sources other than salary. This certificate will be in addition to the other mandatory certificates to be issued to the Backward Classes.

You are requested to issue necessary instructions to all the District Revenue Authorities under your kind control to issue the Income Certificate as per the proforma (**Annexure X**) attached to all the BC-A, BC-B Category Candidates desirous of seeking admission in MBBS/BDS Courses in the State of Haryana.

This may be treated as MOST URGENT as admissions to MBBS/BDS Course is due in the 3rd Week of June 2019.
